# **Global connections**

This edition of The Wrap Up is from sunny West Sussex, where I am spending time with family and meeting with the packaging and recycling sector in the UK and Europe.

I met Dr Margaret Bates, head of the UK packaging EPR scheme administrator PackUK and Karen Graley, Head of EPR Producer Responsibility organisation to discuss the implementation of the UK's EPR system. PackUK sets EPR fee rates for household packaging, will collect fees from producers, and pay councils for managing household packaging waste. Producers will start paying fees in October, and "simpler recycling" will be introduced in 2026, with soft plastic kerbside collections starting in 2027.

Since attending my first Recoup conference in 2022, we've benefited from their expertise to help set up the soft plastic recycling kerbside trial in Nelson and evaluating end-of-life options for hard-to-recycle plastic. It was extremely productive spending time with Stuart Foster and his team.

In our pursuit of sustainable endof-life solutions, we have funded Plastoil to conduct a feasibility study for establishing an advanced chemical recycling plant in New Zealand. In 2019, I visited the initial Plastoil prototype unit in Prague; it was therefore a significant development to visit the ENESPA AG Research and Development facility in Hamburg this month, where the Plastoil units are manufactured. The system, which is operational in Germany, Finland, Australia, and Brazil, now includes a custom pre-treatment system with a modular pyrolysis unit. This configuration is well-suited to the size, scale, and geography of New Zealand's waste management needs for soft plastics.

I will visit J&B Materials Recovery Facility in Hartlepool to examine Newcastle's kerbside soft plastic recycling process and discuss the Flexcollect programme with Ecosurety. Additionally, I will attend the Environmental Packaging Live conference, which will cover EPR, reuse, data systems, and infrastructure needs for a circular economy.

# **KERBSIDE RECYCLING TRIAL IN NELSON**

Following the Nelson City Council's discussion regarding the next steps for the soft plastic recycling kerbside trial, (Nelson City Council Meeting on 1 May 2025), the Council has voted in favour of supporting further discussions on kerbside trials. Feedback from 74% of households participating in the trial indicates overwhelming support for its continuation, with 98% of respondents expressing interest in an additional trial to evaluate collection via the council collection bin.

Nelson Mayor Nick Smith has expressed strong support for this initiative, extending his gratitude to The Packaging Forum and the participating households that are pioneering this kerbside soft plastics recycling scheme in New Zealand.

To achieve further progress, additional work with the Council will be necessary. Considering this, we have decided to extend the current trial of orange bags until the end of 2025. This extension will allow sufficient time for discussions with council officials regarding potential implementation and to establish a comprehensive timeline. Most households have indicated that they do not require a fortnightly orange bag collection. Consequently, we have moved to a four-weekly collection schedule, replacing the previous fortnightly two-day collection run.

# NEW & INNOVATIVE TECHNOLOGIES PLASTOIL – ENESPA

Ben Richters, CEO of ENESPA, highlighted their significant R&D investment in developing plasticto-oil pyrolysis units. The NeoOil P5 system, resulting from extensive R&D, includes pre-treatment, a pyrolysis module, and a tank farm. ENESPA's Hamburg lab conducts precise analysis of pyrolysis oils and gases, and they engineer modular chemical recycling plants for the global market.

## Baseline Report – Resources and Waste Policy Programme Evaluation for England

The Department for Environment, Food and Rural Affairs (Defra) commissioned Ipsos UK, Technopolis, and Ricardo in 2022 to evaluate the Resources and Waste Policy Programme in England. This report presents baseline data from the first year of evaluation.

- Circular economy behaviour is prevalent but limited by barriers. Businesses are improving circularity through recycled materials and incentives for reuse and recycling, although substantial changes to business practices remain minimal.
- Consumers prefer reusable products, but availability of these options remains a challenge.
- Recycling willingness is high, but contamination issues exist. Many individuals do not check recycling labels, leading to missed capture and contaminated waste.
- Glass and metals are frequently recycled or reused, while food and plastic waste often ends up in landfill or energy recovery.
- Progress has been made in reducing plastic waste and pollution. Plastic packagin has declined by 3% from 2019 to 2021, and recycled content increased from 9% to 24% between 2018 and 2022-23.
- Waste crime is a growing issue in England, with significant illegal waste management reported and many illegal waste sites identified.

# Soft Plastic Stewardship Australia

SPSA is a not-for-profit entity with an Initial Board composed of directors from brands and retailers that are funding the scheme's establishment: Sandra Martinez (CEO, Nestle), Laurie Kozlovic (MD of Sustainable Impact, Woolworths Group), Bill Heague (GM, Mars Food Australia), Brooke Donnelly (GM Sustainability, Coles Group), and Paris Golden (MD, McCormick & Co.). The board will later include independent directors. It oversees the scheme's governance, operation, and compliance with community, environmental, financial, and legal obligations.

Subject to ACCC approval, SPSA plans to collect levies from manufacturers and retailers based on the amount of soft plastic they introduce into the Australian market.

#### European Commission Environment Council discusses recycling issues

The European Commission has urged member states to address the economic challenges facing the EU recycling sector at the 17 June Environment Council meeting. Key issues include high energy costs, a price gap between recycled and virgin materials, competition from low-cost imports, and a mismatch between recycling capacity and market demand. Proposed measures include improving EPR schemes, intensifying customs controls on imports, and adhering to battery removability guidelines to reduce fire risks.

### Fost Plus – Belgian scheme reports increase in plastic recycling rate from 69% to 71%

The PPPS scheme design report showcases Fost Plus for effectively sorting and recycling household packaging waste, using the "blue bag" to collect plastic, metals, and drink cartons (PMD) simplifying home sorting.

Fost Plus has released its 2024 activity report. In 2024, Belgians sorted nearly 80kg of packaging waste per person, including 25.7kg of PMD, 24.7kg of paper and cardboard, and 28.7kg of glass. Fost Plus reported a rise in the recycling rate for plastic packaging from 69% to 71%, with 4,400 additional tonnes recycled. Despite an increase in sorting errors, awareness campaigns and partnerships with waste operators have led to a gradual improvement in correct sorting in PMD bags by early 2025.

# Ocean Bound Plastic guidance from UK FSA

The UK Food Standards Agency has issued new guidance advising businesses against using oceanbound plastics (OBP) in food packaging, particularly for meat, poultry, and fish products sold in UK supermarkets, due to safety concerns. The term "abandoned environmental plastic" refers to plastic meeting OBP criteria that has been discarded into the open environment, posing risks from factors like degradation and UV exposure. This excludes plastics collected through waste disposal systems such as private or public waste collections or recycling bins.

A refurbishment project at Te Wānanga o Raukawa – Pā Reo in Ōtaki, New Zealand, transformed an old toilet block into a modern, durable, and visually appealing space using saveBOARD exposed prefinished panels. This effort saved 431kg of  $CO_2$  and 490kg of packaging waste, preserved the original structure, and significantly reduced the carbon footprint.
